

Location:

The Mitchell Community Centre is within the Riverside Area, Central Ward at the heart of the community covering Bridlington Avenue and Fountain Road. The Centre is surrounded by a mix of rented and private housing and is located a short distance from the A1079, approximately 1 mile north west of the City Centre.

Accommodation:

The property is a purpose built single storey Community Centre with large hall, meeting rooms, WC'S, kitchen facilities, plant room, storage and own enclosed car park



Utilities / Services:

Water, electricity and gas supplies to the property as well as a telephone line. The Centre has gas central heating to most of the accommodation. (Note: Initially, there maybe some financial assistance (up to 50%) of the costs of the utilities from Hull City Council but the tenant will be expected to become fully self funding in due course).

Planning

The property falls within Class F2 of the Use Classes Order 1987 (as amended). Any interested applicants should make their own enquiries to satisfy their planning requirements.
