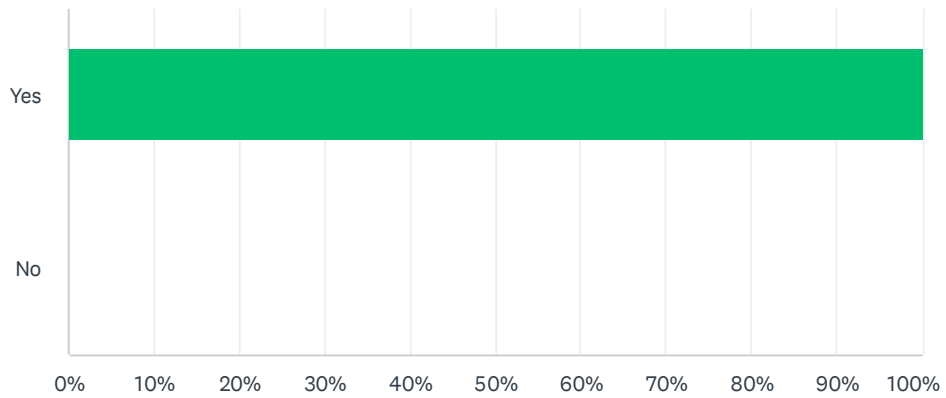


# Q1 Are you aware of your safeguarding commitment and legal obligations?

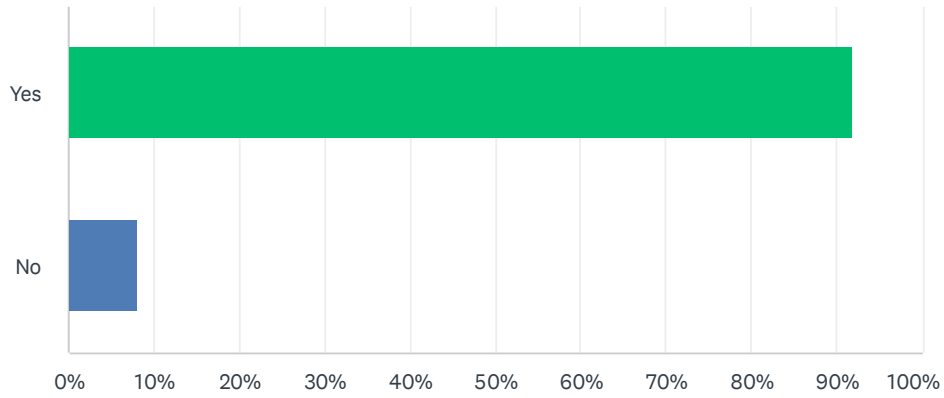

## Q2 Do you have a safeguarding policy in place?

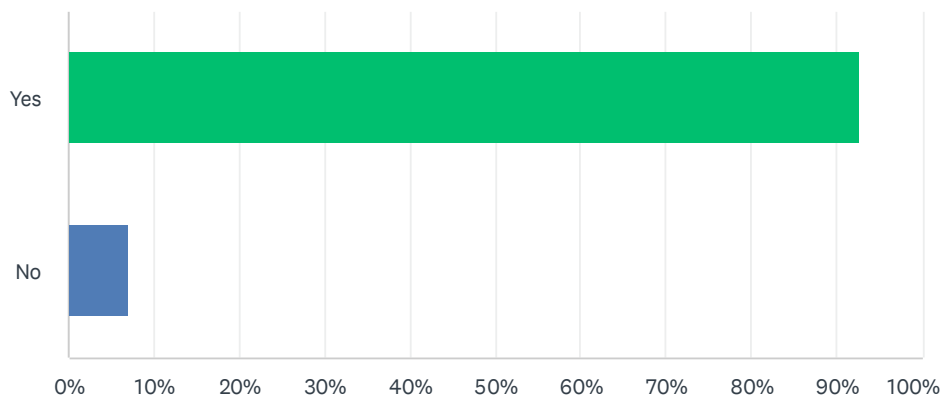

### Q3 Is it updated regularly?

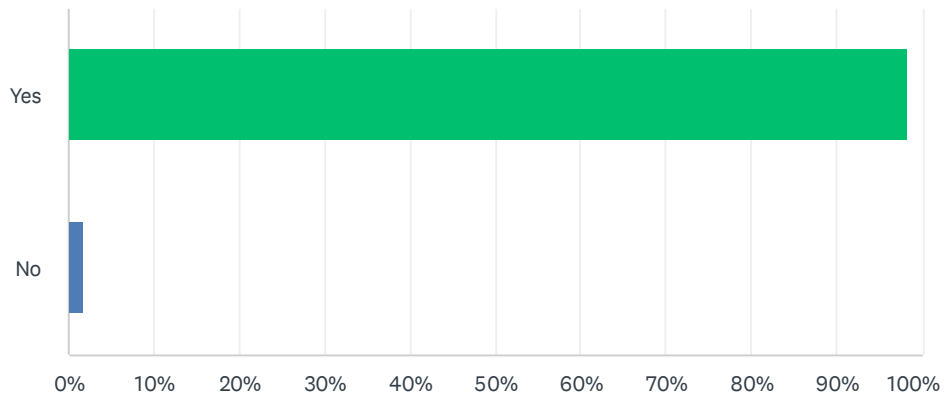

### Q4 Are staff and volunteers aware of the policy and its use?

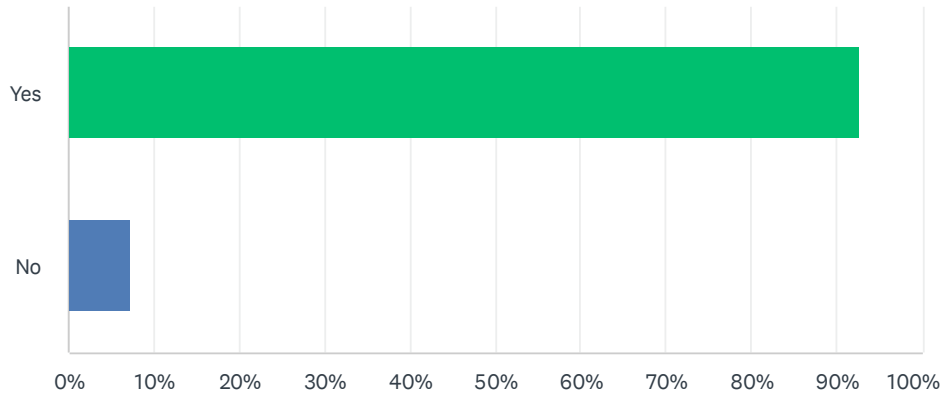

### Q5 Are your Trustees/Committee aware of their safeguarding commitment/ legal obligations?

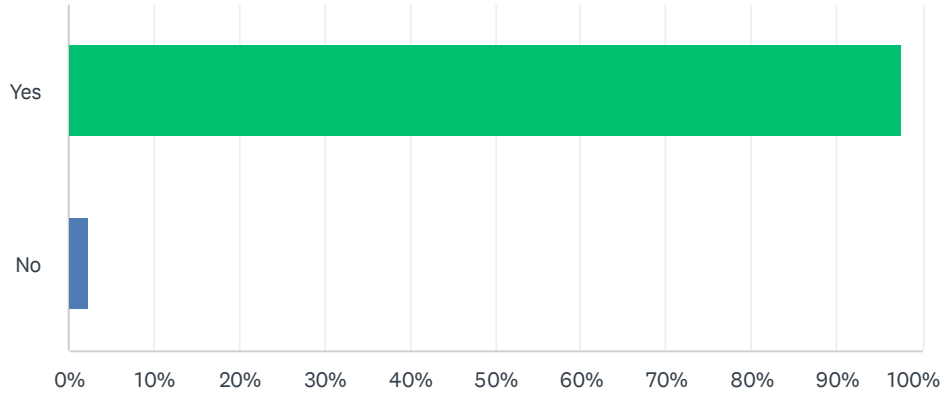

## Q6 Would you know what to do should you have a serious safeguarding concern for an adult or child?

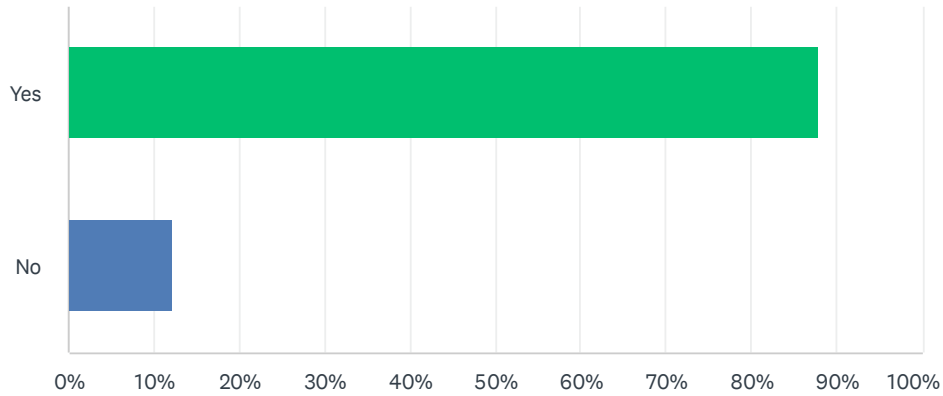

## Q7 Would you know what to do if an allegation was made against a member of staff/volunteer?

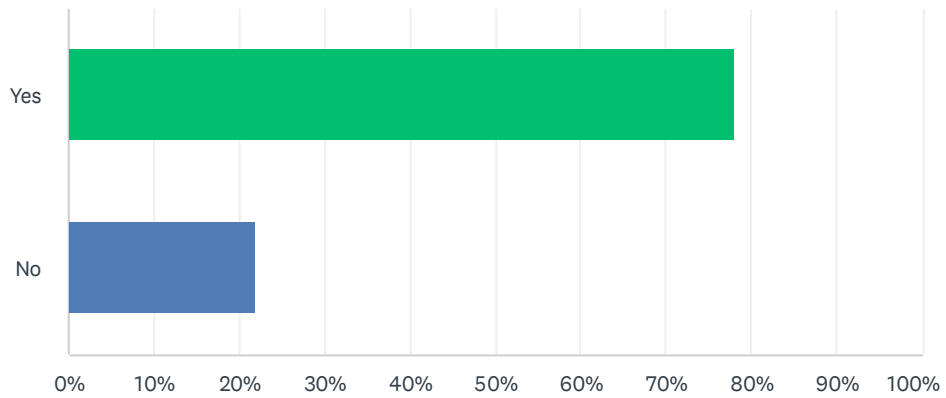

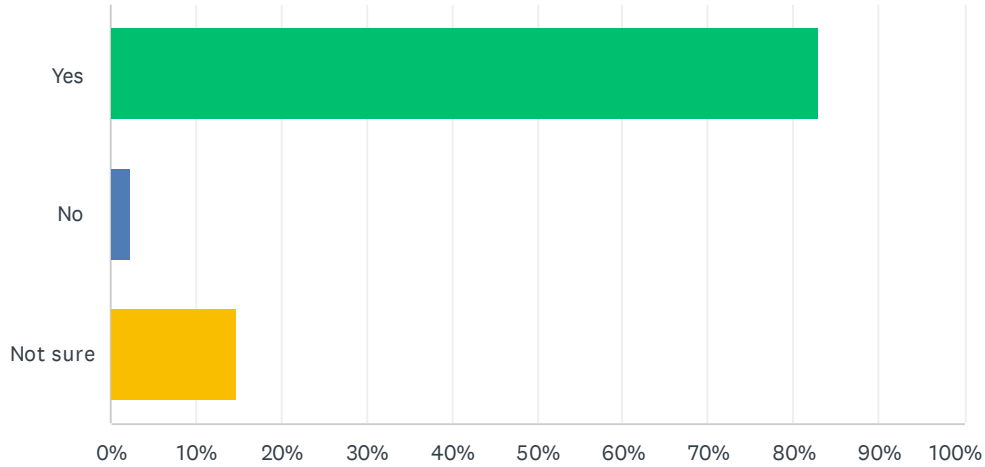

## Q10 Did you feel confident that you could handle a safeguarding concern following the training?

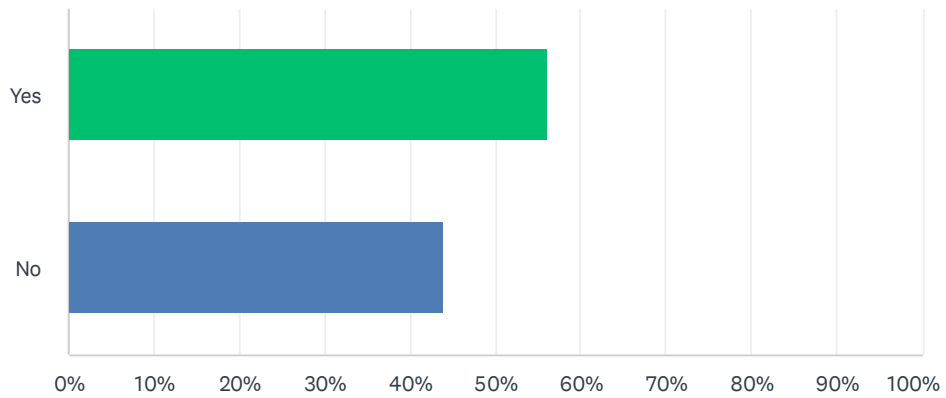

### Q11 Do you know what a safeguarding section 11 audit is?

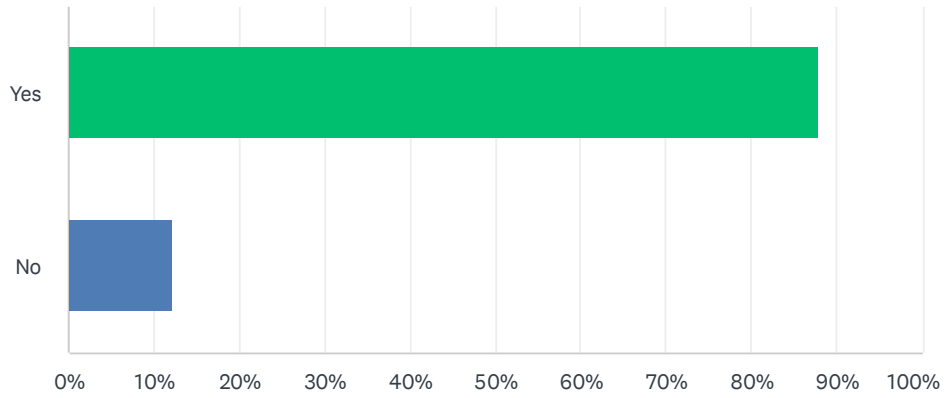

## Q12 Do you have a Designated Safeguarding Lead?

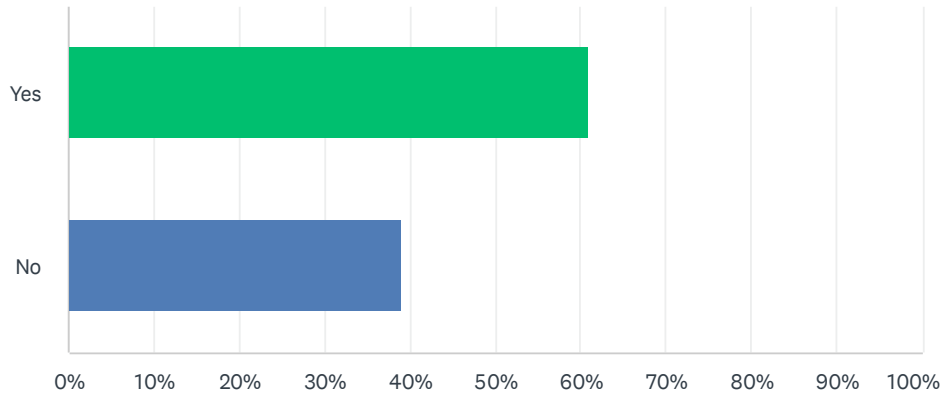

### Q13 Are you aware of the changes to the legislation working together to safeguard children?

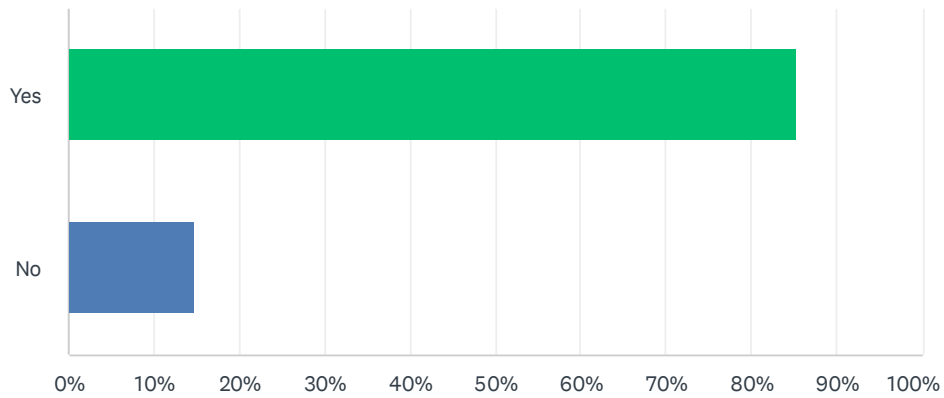

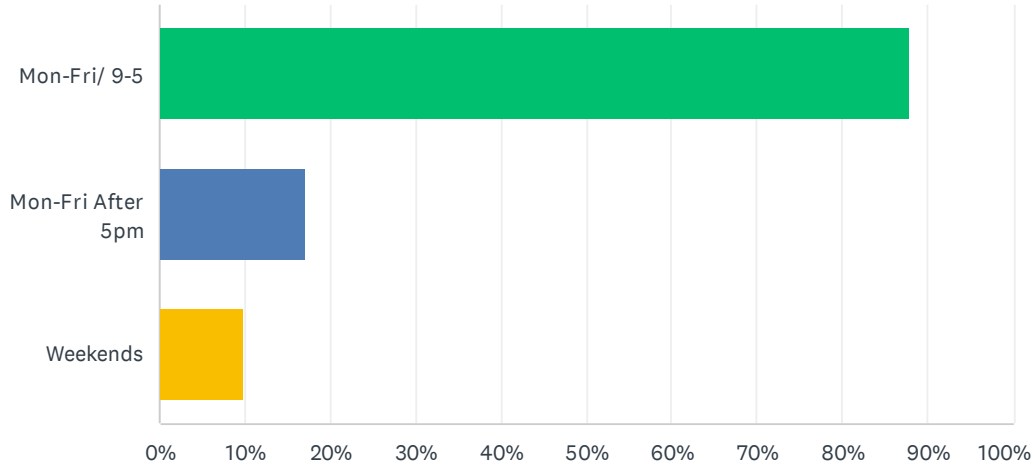
